Here is a summary of a few important rules from the Internal Regulations that apply to all memberships:

- The membership fee will be deducted per study year. A study year starts on 1 September and ends on 31 August. For new members who register on or after 1 March, a discount exists on their first membership fee. As long as a member doesn't cancel their membership, their membership will be automatically renewed each study year.
- A la Kart yearly serves a few bar shifts in the UT Sports Cantina. An A la Kart bar shift is split into shifts of 3,5 hours. Each member is expected to fill at least two shifts per study year. Each study year, a deposit will be deducted which will be reimbursed by filling shifts.
- The membership fee and cantina shift deposit will be determined yearly at the annual general meeting and will be mentioned in the Internal Regulations. The membership fee will be deducted halfway through the study year. For new members the deduction of the first membership fee could take place earlier. All deductions are to be announced at least two weeks in advance by e-mail.
- Each member is required to report changes to their personal data (as filled in on this form) to the secretary. It is the responsibility of the member to be available by e-mail or phone.
- In case of a member causing damage to the kart, a claim to the 50%-rule is made. A la Kart will then agree to pay 50% of the damage. A la Kart will pay up to 100 euro. A la Kart will pay all damages caused by wear. Damage caused by malicious behaviour or intent will not be covered by A la Kart.
- Cancellation of your membership should be communicated to the secretary. Cancellations by e-mail are allowed. The secretary will process the cancellation of your membership. The cancellation of your membership will take place at the first following 1 September or 1 March. Cancellations in retrospect are not possible.
- The use of the karts in terms of personal injury is completely at one's own risk.
